



**Heavy-Duty
Propagation Mat**

INSTRUCTIONS:

1. Lay the RHM-HD on a flat stable surface with the power cable side up.
2. Plug RHM-HD into an approved thermostat. We recommend the Phytotronics RHT-4D Thermostat.

WARNINGS:

- ▶ Failure to connect the RHM-HD to a thermostat will void the warranty. We recommend the Phytotronics RHT-4D Thermostat.
- ▶ Make sure the surface beneath the RHM-HD is free of sharp points or objects that may puncture or damage the mat.
- ▶ As with all electrical products, use care when working with or around the RHM-HD mats. Avoid getting cords & plugs wet and/or cut/chafed as an electrical short may occur.

CONSIDERATIONS: (PLEASE READ BEFORE USE)

- ▶ Position the RHM-HD on your desired surface before putting the weight of flats or pots on it.
- ▶ Since soil temperature will be constantly maintained at a higher level, soil media and plants will dry more quickly and will require more frequent watering.
- ▶ A consistent amount of soil moisture will maintain the most even heat.
- ▶ Consider covering pots or flats with a layer of plastic to retard the rate of evaporation. Once cuttings have rooted or seeds germinated, the covering can be removed and the thermostat setting reduced or turned off completely.
- ▶ Young plants can be illuminated with HID lights to keep early growth compact until the new plant can be transplanted.
